ACCELERATED POLITICAL SCIENCE SEQUENCE

Program Admissions Requirements

The Accelerated Political Science Sequence (APS) is a pathway in the Master's Program in Politics and Government. The accelerated degree program is available to high-achieving students that are interested in advanced study and the opportunity to complete a Bachelor's and Master's degree in 5 years. Once accepted, the student will be expected to take graduate level credit during their senior year. These courses will count for both the undergraduate and graduate degree. Students that qualify must apply during the spring of their Junior year. Admission is based upon program capacity and academic competitiveness. Application procedure and deadlines are located on the Department of Politics and Government website.

Acceptance into APS includes acceptance into the Master's Program in Politics and Government, if the student is in good standing and has made progress towards their Master's degree in their Senior year. A student is still required to apply to the Graduate School to transfer over to graduate only status. This application will be required in the spring of the APS student's Senior year.

Accelerated master 's degree (AMD) programs offer high achieving students the opportunity to complete their bachelor 's degree and master 's degree in a faster time frame than each degree separately. Students will take both graduate and undergraduate classes when they have junior or senior status and seamlessly transition into their master 's degree program. Students admitted into an accelerated master 's degree program may count a maximum of twelve (12) hours or 33% of course work (whichever is higher) towards both the bachelor 's degree and master 's degree. The undergraduate accelerated sequence should indicate a minimum number of graduate level credit hours that should be completed in order for the student to graduate in that sequence. Courses must be at the 400-level or be a dual credit 300 level course in which the student completes graduate student requirements as outlined in the syllabus. This program seeks to provide opportunity for select advanced undergraduate students to graduate with a BS/BA and a MS/MA combined in 5 years.

4. Provide a rationale of proposed program.

The department was approached by the university for the creation of the program to provide greater opportunities to high achieving Political Science undergraduate students. This program would enhance our ability to recruit high quality students. The program is modeled off the Accelerated Master's Degree program in the Sociology/Anthropology Department. We expect demand will increase as the university promotes the program.

Comments from Version 1 from Te-Yu Wang (Department Curriculum Committee Chair):

Need to make changes

Comments from Version 2 from Todd Stewart (College Curriculum Committee Chair):

Hi. We voted to reject this proposal yesterday. We think that some version of this will be acceptable, but there are important omissions along with some unclarities with the current version. Here are our concerns: (1) All proposals to create new programs require a Financial Implications Form, available through the Provost's office. As far as we can tell, none has been submitted for this program. (2) In the copy, you have: Required courses (22 hours): POL 100, 106, 138, 140, 151, 161, 296, 398.01. We don't know how to read the commas - are they "ands" or "ors"? Could a student, for example, earn most of these 22 hours by taking 398.01? Or are they required to take all of the courses on the list? The copy isn't clear about this. (3) Are students required to take any 400-level courses? It appears that they are not in the proposed copy. On p. 110 of the grad catalog, it seems that Masters students are required to take POL 496 and one of POL 461 or 497. So, what is proposed seems inconsistent with the current MA requirements. (4) Related to (3), we don't fully understand what this proposal means to do. Does it concern only the undergrad requirements for students, who then are also subject to Masters requirements as explained in the grad catalog? Or would a student completing this as listed here earn a BA and a MA? If the latter, the copy does not make clear whether a student would receive a MA or MS. If the former, adding a sentence to the catalog copy explaining that students must also meet requirements in the grad catalog to earn a grad degree would be helpful to students, so they are aware that they will have to meet extra requirements explained elsewhere. (5) The catalog copy make reference to an "AMD sequence." Does this mean: Accelerated Masters Degree sequence? Whatever the case, students are not likely to know what "AMD" means, so this should be mentioned by full name. (6) The proposed rationale could be better. E.g., why would this proposal be helpful to the department, or to students? What sort of demand d

Comments from Version 5 from Todd Stewart (College Curriculum Committee Chair):

Hi. We voted that this proposal should be revised and resubmitted. We identified two issues. (1) In light of changes at the graduate college, dual-credit 300-level course are on the way out, to be replaced by 300- and 400-level versions (with 400-levels being for grad credit). So, this affects the catalog copy you propose, potentially in a few ways. You have:

All 300 level courses must be taken for graduate credit.

At least 6 of 12 hours of elective courses must be at the 300- level.

Students in the Accelerated Sequence must consult with their advisor and the instructor prior to the start of the course to ensure approval for graduate credit for all 300 level courses.

This is going to create serious problems going forward for accelerated MA students as dual-credit 300-level courses are phased out. As you revise this catalog copy, you may discover that you need to create 400-level equivalents to 300-level courses so that students may earn grad credit. This is a change coming from the graduate school not the CAS curriculum committee.

(2) We can't tell if students in the accelerated MA will have the option to do a thesis or not. If so, then we think that two different 5-year plans of study are needed, one reflecting the no-thesis option, the other the thesis option. If the thesis option will be unavailable to students, then the catalog copy should say something to make this clear. In general, it isn't a good idea for catalog copy to incompletely describe the requirements and punt to the graduate catalog. Undergrads trying to navigate this are likely to find this sort of thing very confusing.

Comments from Version 6 from Christopher Hamaker (College Curriculum Committee Chair):

The CAS Curriculum committee voted to Revise and Resubmit. When you submit an updated proposal, we will review it again. The issues identified were:

- Looking at the list of courses possible elective courses, POL 499 (Independent Research For The Master's Thesis) is not listed, but it appears from the Thesis Option plan of study that 6 hours of POL 499 are being used as "elective hours" at the 400-level. Our recommendation is to add "6 hours of POL 499 counts for 6 hours of the elective courses if a student chooses the thesis option" or something similar to the last line above the "note".
- The list of possible elective courses should have 'POL' in front of the numbers, there should be comma after 483.
- The catalog copy says "A maximum of 12 of the 18 hours of elective credit must be taken at the 400-level." Should it be minimum rather than maximum? If a student chose 18 hours of 200-and 300-level electives with the non-thesis option, all their POL classes would be at the undergraduate level.
- In the list of required courses, it should read '398a01' rather than '398.01'
