This Campus-Wide Minor in Entrepreneurship is a cross disciplinary approach to teaching basic entrepreneurial skills to undergraduate students from diverse major programs. This Minor is intended to serve the entire campus undergraduate community and provide them with a hands-on, transformative approach allowing them to better practice their passions through private business endeavors.

Currently, entrepreneurship education is not open and available to non-business majors. This minor will fill that void and open up both entrepreneurship education and basic business education to all those outside of the College of Business.

For example, a graphic design major or recreation major will now gain the additional insight of creating and running a small business to increase their likelihood of success in their respective fields.

All courses used in this proposal have been developed and are currently being taught and are fully enrolled. In the case of MQM 328 - currently titled Entrepreneurship in the Arts, we request an editorial change be made to the title in this curricular proposal process. The revised title for MQM 328 should now read, Entrepreneurship (E) for Non-Business Majors. Students within IDS 113, MQM 128, and MQM 328 have expressed a strong interest in this proposed E minor in order to round out their education at Illinois State University.

The number of current faculty will be adequate to provide instruction for the Minor in Entrepreneurship based upon the structure of the program. Any new hires necessary to provide instruction would be NTT to cover instructional "gaps" and the Means' Center will cover those costs.

MQM 328: This course will be offered to students once per year (i.e. Fall of each year) and taught by selected faculty (either NTTs or Coleman Fellows) and covered by the College of Business Department of MQM.
