Proposal: Master of Music in String Pedagogy Financial Implications

- A. Yes. No new operating funds are required.
- **B.** The proposal will require no new faculty; string studios are not at capacity, and this degree will hopefully help boost studio numbers. Additionally, the string faculty have agreed to take on the following new duties associated with this degree:
 - Each string faculty member has agreed to teach a Pedagogy and Literature course (MUS 330A61-64, as applicable) at least once every 4 semesters. These are specific to each instrument (violin, viola, cello and bass) and will be in addition to the current String Pedagogy and Literature course (MUS330A60) team-taught by Dr. Lewis and Dr. Ransom
 - Each string faculty member has agreed to be an advisor for the exit requirement: Final Project in String Pedagogy (MUS 475) as needed
 - Dr. Lewis and Dr. Ransom have agreed to supervise the new decimalization: MUS
 498A50 Professional Practice in String Pedagogy
 - See attached letter from the string faculty (reference to new courses "Readings in String Pedagogy" and "Music and Literacy" have since been changed to "Professional Practice in String Pedagogy")
- **C.** The program will not require any new staff. The addition of approximately 4-8 new MM students per year will not significantly impact staff (advising or otherwise) requirements. Angelo Favis will be the advisor along with other Master of Music students. This degree does not require any licensure.
- **D.** There will be no new facility needs. The addition of approximately 4-8 new MM students per year will not significantly impact facility requirements. Additionally, string studios are not currently at capacity.
- E. Current library resources are more than adequate for this degree, thanks to established degree offerings in related fields (such as Master of Music Education, Master of Music in Performance, and various undergraduate education degrees). Music Librarian Anne Shelley has been working with the string area to build a good body of string pedagogical materials for over 5 years: "Milner Library actively collects materials to support string pedagogy courses and activities at Illinois State University. The music librarian has worked closely for several years with Dr. Ransom and Dr. Lewis to purchase important string methods publications. Methods acquired are both historical and current, and the library strives to provide complete methods."
- **F.** There are no other additional funding needs.
- G. There are no current sources of temporary funding, except for one GA position; see below.

H. The School of Music has supported three Graduate Assistantships specifically for string students for a number of years. One GA is funded directly from the School of Music; one is funded by the Community School for the Arts; one is funded by the ISU String Project. These are expected to continue for the foreseeable future. There is also a 4th GA primarily funded by a grant for the 2017-18 school year. Masters students seeking a degree in String Pedagogy would have the desired skills needed for all of these assistantships and would be very competitive candidates.

Dr. Parsons,

On behalf of the string faculty, please accept this letter of support for the addition of a new master's level degree sequence in String Pedagogy. We believe that adding this degree will help attract new graduate level string students in all studios. We know that this degree is growing in popularity; a number of institutions have recently announced the addition of this degree, and students who have applied for a MM in performance or MMEd at ISU have also applied for MM in String Pedagogy degrees at peer institutions. Also, recent ISU graduates (in the BM and BMEd programs) are seeking this degree at peer institutions as they look to continue their education at the graduate level. We are well-poised to offer this degree because of our two teaching-training programs currently operating successfully (String Project and MusicScores!); we also currently have 3 GAs related to string teaching.

The new degree sequence will require additional duties of the string faculty:

- Each string faculty has agreed to teach a 2nd level of String Pedagogy at least once every 4 semesters, specific to each instrument (violin, viola, cello, and bass)
- Each string faculty has agreed to be a supervisor for the exit requirement: Final Project in String Pedagogy, as needed
- Kate and Adriana have agreed to teach the new course: Readings in String Pedagogy, to be offered at least every four semesters; they will take turns
- Kate and Adriana have agreed to teach the new course: Music and Literacy, to be offered at least every four semester; they will take turns

We willingingly accept these additional duties.
