Interdisciplinary Early Intervention Sensory Disabilities Sequence

- 33 total hours are required to complete this sequence.
- 24 total hours in major department are required.
- 3.00 Cumulative GPA is required for retention in this major.

Required Courses (33 hours): SED 409, 420, 421, 423, 440, 482, 498A03 (6 hours); CSD 406, CSD 420 or CSD 412; EAF 410

The required courses must be completed with grades not lower than a "C" while maintaining a cumulative GPA of at least a 3.00.

Prerequisite: Students must have completed a bachelors degree or higher in Special Education with an emphasis in blind/partially sighted or deaf/hard of hearing.

3. Provide a description for the proposed program.

This interdisciplinary sequence provides teachers of the visually impaired and teachers of the deaf with knowledge and skills to meet the unique needs of infants and toddlers who have sensory disabilities and their families. While the program will provide an overview of the impact of sensory loss on early development, an intense focus will also be provided on language, communication, and feeding issues common to this population. A variety of practicum and clinical experiences with children and families will allow students to apply knowledge and skills to professional practice.

4. Provide a rationale of proposed program.

Infants and toddlers with disabilities and their families are provided services through Part C of Individuals with Disabilities Education Act (IDEA). When very young children have sensory disabilities, they require support from specialists who understand the needs unique to both early development and sensory loss. In Illinois, licensure and training for teachers of the deaf and teachers of the visually impaired focuses on IDEA Part B services. Therefore, additional training is needed to understand the impact of sensory loss on early development. Further, children with sensory disabilities often experience struggles in the development of language, communication and feeding. Specialized training that capitalizes on interdisciplinary learning will prepare professionals to meet the unique needs of this population.

5. Describe the expected effects of the proposed program on existing campus programs (if applicable).

The new sequence will require the CSD department to offer additional sections of the courses in this sequence (CSD 406, 412, 420). The CSD department is aware of this and a letter of acklowledgement is attached.

6. Describe the expected curricular changes required, including new courses. If proposals for new courses that will be or have been submitted, please reference those related proposals here:

A new sequence will be offered (see other proposal submitted under new sequence). Students in the new sequence will take 15 hours of existing coursework in the Department of Special Education (SED 409, 482, 445) and 9 hours of new coursework related to early intervention sensory disability. The 3 new, 3-hour courses that have been submitted are: SED 420 (3 hours) SED 421, and 423. See submitted proposals for these courses.

Anticipated funding needs and source of funds.

The US Dept of Special Education, Office of Special Education has requested proposals for projects that can meet critical personnel needs. A 5-year grant proposal is being submitted that would supply funding for students electing this proposed Interdisciplinary Early Intervention Sensory Disabilities sequence. This grant would fund a total of 36 students from two cohorts to complete a master's degree.
