Re: Proposal for Leadership and Social Justice Sequence in Political Science Major UCC Executive Summary

The Department of Politics & Government proposes a new Leadership and Social Justice sequence within the Political Science major. The sequence will allow students with career interests in human rights/social service agencies or the broader not-for-profit sector to focus on relevant course work and outside educational activities (and to be recognized for such specialization). In addition to completing specified departmental course work, the student must complete either an internship, a cognate area (18 hours of appropriate course work outside the department), or an off-campus study program (the best example of which would be study abroad).

Anyone wishing to complete this sequence must meet both the requirements for the major and those for the sequence. A student following the sequence meets most of the sequence requirements simply by choosing the correct subset of courses in meeting the major requirements. In fact, completing the sequence with an internship or approved off-campus study program would, with proper planning, involve no more than the 33 hours required for the broader major. The student completing a cognate area could keep the number of total program hours in check by including in the 18 cognate hours some courses that would also count toward General Education requirements.

Because no new courses are to be created, the department does not foresee the need for additional faculty or library resources. The University Curriculum Committee supports this proposal with no dissenting votes.

Date of Sequence Implementation: Fall 2005

Rationale for Proposal: Many of our graduating majors are getting placements in Not for Profit organizations. Many others aspire to work in human rights and social justice types of groups. Such jobs are growing at a fast pace. This proposed sequence would aid our students in their objectives. It will provide them with the tools by which to understand such tasks and give them a better chance at related careers after graduation.

Expected Curricular Changes: The proposed sequence simply tracks students into existing courses. No new courses are planned at this point.

Funding Needs: Because the proposed sequence is internal to the Department and its majors only, no new funding will be required.

Leadership and Social Justice Sequence:

- 16 hours POL core courses required: POL 105 or POL 106; POL 140 or POL 141; POL 150 or POL 151; POL 161 and POL 209 (4 hours).
- 12 credits in Politics and Government Leadership in Public Affairs and Social Justice Issues courses, and either an internship component, approved off-campus course of study focused on issues of leadership and social justice, or completion of approved cognate courses outside of the department (see below)

- 2. Six approved cognate courses (18 hours) from the following: AGR 201; ANT 175; BSC 202; CJS 102; COM 178, 329, 375; ENG 261; GEO 140; HIS 111, 230, 239, 262, 268; IDS 111; PHI 104, 238, 246, 248; PSY 131; SWK 125; SOC 108, 111, 240, 264, 341, 361, 366; WS 120. NOTE: Students may substitute other cognate courses with approval of the sequence advisor.
 - 3. Approved off-campus study program with emphasis on leadership and social justice. (Programs can vary from 12 to 17 hours.)
- NOTE: Students are required to develop their Leadership and Social Justice Sequence in consultation with a departmental sequence advisor.
