They will take 1-2 classes per semester, excluding summer as graduate courses are not offered in the summer. It is conservatively projected that each student will take 9 hours per year.

- a. The Physical Education Teacher Education (PETE) sequence will be supported with current faculty. They will offer one sequence specific course per semester. Their current faculty can cover these courses with no additional need for faculty or other resources. The PETE faculty has previously been understaffed until the fall 2009 semester. Due to that understaffing, sections of courses were merged and/or eliminated. With the program at full instructional capacity, the graduate courses can be reinstated. All PETE faculty, with graduate faculty status will share the responsibilities of student advisement.
- b. The PETE sequence graduate students will most likely be part-time students who are practicing teachers. They are not likely to seek graduate assistantships so no new funding is needed, nor does the program reduce assistantships typically afforded to other KNR sequence areas.

- c. Since an undergraduate program exists, equipment is already available to the faculty. No new equipment is needed. At this time, the PETE graduate program is not seeking to reduce assistantships in other programs.
- d. The KNR librarian, Sharon Naylor, has worked diligently to ensure that the library resources are sufficient for a master's degree in KNR. Many of the KNR sequences use the same library resources and no new materials are needed.
- e. No additional clerical staff will be needed as this graduate sequence will follow the same processes and procedures already in place for the KNR graduate sequences including the application process and program management/assessment.
