Applied Community and Economic Development Sequence:

The Applied Community and Economic Development (ACED) is a 37-hour interdisciplinary program designed for students in the Cultural Anthropology Concentration who intend to pursue careers as economic and community development professionals. To qualify for the ACED sequence, a student must be a returning Peace Corps volunteer or have equivalent domestic or international experience with other agencies, and be approved by the Anthropology Graduate Coordinator. Program requirements include required courses in the Cultural Anthropology core (12 hours): ANT 302, 380, 383, and 460; the required courses in the ACED core (13 hours): ECO 490.04 (2 hours), POL/SOC 470 (3 hours), POL/SOC 477 (3 hours), and ECO/POL/SOC 478 (2 hours); and at least three credit hours of a graduate elective course. Students must complete a 11-month paid internship while earning Professional Practice credits (ANT 498, 6 hours). The degree also requires completion of a master's thesis with guidance from Anthropology faculty and enrollement in ANT 499 Master's Thesis (6 hours).

3. Provide a description for the proposed program.

This Applied Community and Economic Development (ACED) sequence will prepare cultural anthropology MA students for professional positions in community, governmental, and nonprofit agencies. Through course work, training, and hands-on experience, graduates of ISU's ACED Sequence in Cultural Anthropology will be uniquely prepared to for employment in positions where cross-cultural understanding, research methods, project management, and community outreach and development are required. The 37 hour interdisciplinary program requires 12 hours of cultural anthropology, 10 hours of ACED core courses, a 6-hour paid internship; and a master's thesis in cultural anthropology (6 credit hours). The attached model plan of study also includes 3 hours of Independent study in anthropology (but a graduate elective course in a cognate discipline may also be taken depending on the student's experience, goals, and specialization interests).

4. Provide a rationale of proposed program.

The ACED Sequence in Cultural Anthropology has emerged through partnerships between the Department of Sociology and Anthropology and the Stevenson Center. The ACED core complements existing cultural anthropology courses to prepare students to work as professional anthropologists in applied anthropology settings. Applied anthropology is the application of the principles, theories, methods and approaches of anthropology to the interdisciplinary identification and solution of human problems. Professional applied anthropology most often find employment in education, outreach, and administration/management (See http://www.aaanet.org/resources/departments/upload/Changing-Face-of-Anthropology.Short-Report.pdf). The ACED Sequence in Cultural Anthropology will appeal to students seeking professional qualifications to work or advance their careers in a variety of public and private agencies. Through a combination of coursework, research, and hands-on experience, graduates of this sequence will be well-positioned to work as professional anthropologists.

5. Describe the expected effects of the proposed program on existing campus programs (if applicable).

The proposed ACED sequence in Anthropology is expected to enroll only 1-2 students per year. This small increase in enrollment will have minimal effect on other campus programs. This sequence allows the Stevenson Center for Community and Economic Development and the newly expanded MA program in Anthropology to offer a unique and specialized program. The sequence offers both programs measured growth with the addition of highly motivated students.
