#### MAJOR IN HUMAN DEVELOPMENT AND FAMILY SCIENCE

#### Degrees offered: B.A., B.S.

Students majoring in Human Development and Family Science will find rewarding careers working to improve the lives of individuals, families and communities.

Human Development graduates are prepared to enter a variety of service-oriented fields, such as psychology, public health, public policy, child care, education, child/family advocacy, and social work. Common employers of human development graduates include non-profit organizations, child care centers, preschools, private educational settings, residential facilities, camp settings, colleges and universities (non-teaching positions), state, local, and federal government agencies, and hospitals and other organizations/businesses serving the needs of children.

Family Science offers an interdisciplinary approach to understanding the well-being and healthy development of individuals and families over the lifespan, including relationships and roles within the family as well as the family's interactions with broader social institutions. Graduates with an undergraduate Family Science degree can work in a variety of settings including parent/family life education, non-profit organizations, residential facilities, hospitals, child protective services, crisis centers/shelters residential treatment facilities, aging and assisted living facilities, child care, colleges and universities (non-teaching positions), child/family advocacy, state, local and federal government agencies, and employee assistance programs.

The Human Development and Family Science undergraduate degree program provides a foundation for advanced graduate study in social work, marriage and family therapy, psychology, counseling, child life, family science, child/human development, gerontology, early intervention, occupational therapy and religious studies.

# 3. Provide a description for the proposed program.

The Human Development and Family Science degree prepares students to provide educational, preventive and intervention services to individuals and families to enhance personal, family and community well-being. Students develop advocacy skills along with the ability to assist people of all ages with choices for individual and family well-being.

# 4. Provide a rationale of proposed program.

Faculty in the Department of Family and Consumer Sciences have been contemplating this change to separate degree programs for a number of years. As part of our recent program review, we investigated programs at similar institutions nationwide. We found that most institutions of our size had Human Development and Family Science programs as stand-alone degree programs housed within more comprehensive departments (like Family and Consumer Sciences). Faculty feel it will make us more competitive in student recruitment, faculty recruitment, and grantsmanship for this discipline area to be a degree program, rather than a sequence area.

The name for the degree program will change from the current sequence name Human Development and Family Resources to Human Development and Family Science in order reflect the terminology used in the field. The field of study that focuses on family relationships and issues is family science. Therefore, the degree program name will reflect the terminology used in the field.

# **5.** Describe the expected effects of the proposed program on existing campus programs (if applicable). There should be no effect of this new program on existing campus programs as this simply modifies the existing sequence in Human Development and Family Relations within the B.A.,B.S. in Family and Consumer Sciences. A separate proposal to delete the sequence once this new program has been approved. Students will be transitioned into this new program which allows more flexibility than the current sequence. Thus time to degree will be preserved for all current students.
